Other Fees

1. Perpetual care – 15% of the sale of a grave/niche is state mandated, and held in trust, for the upkeep of the cemetery for generations to come.
2. Price includes: A plaque for the identification of those inurned (name, year of birth, rose design) which will be of uniform style. Plaque must be ordered at time of purchase or additional fees will accrue. Also included is the cost for inurnment of ONE (1) set of cremated remains.
3. Non-active parishioners are those who may have registered with the parish, but have not contributed time, talent or treasure within the last 7 years. Non-parishioners are those who are not registered with the parish.
4. Infant burial refers to children 2 years of age or younger.
5. Applies to a second set of cremated remains being inurned in a niche – not dependent upon time of inurnment.
6. Applies to year of death plaques not ordered in the same calendar year in which the death occurred.

TERMS AND LIMITATIONS

- **NO SUNDAY OR HOLIDAY BURIALS**
- **Refunds:** Burial Rights can be resold to St. Mary Cemetery only. You will receive 100% of purchase price up until 90 days after purchase. If plaque was produced on Niches at time of refund, the price of the plaque will be withheld. After 90 days, the Burial Rights may be donated back to St. Mary Cemetery for the use of a family in need. If plaque was produced on Niches at time of refund, the price of the plaque will be withheld.
- **Grave Markers/Headstones:** All Grave Markers/ Headstone designs MUST be approved by the Pastor. Any alterations after initial approval must also be approved by the Pastor. Unapproved designs/alterations will be removed from St. Mary Cemetery. Cost for removal and replacement will be borne by you, the purchaser.
- **Re-Issuance of Certificate of Burial Rights (Deed):** \$50
- **Niches and Graves** are sold only to Active Registered Parishioners of St. Mary Catholic Church, St. Clair. Non-active parishioners or Non-parishioners who have immediate family members buried in the cemetery and can prove Catholic Baptism or conversion to the Catholic faith are eligible to purchase.
- **For Niches:** all cemetery general rules and regulations apply. To maintain the beauty and uniform appearance of our columbaria, no additional memorials, flowers, holy cards, decorations, glass or ornamentation of any kind is allowed and will be removed.
- **Payment Options:** Payment in full by cash or check made payable to “**St. Mary Cemetery**”. No credit cards accepted.
- **Other Rules and Regulations:** At time of purchase of Burial Rights, the Rules and Regulations document will be given. This document contains the complete set of Rules and Regulations for the Cemetery. This document can also be found on our webpage www.stmarystclair.com under the “forms” tab.
